

### **Description**

The TFMN5..0 – series are miniaturized receivers for infrared remote control systems. PIN diode and preamplifier are assembled on PC board, the epoxy package is designed as IR filter.

The demodulated output signal can directly be decoded by a microprocessor. The main benefit is the reliable function even in disturbed ambient and the protection against uncontrolled output pulses.








Figure 1. Frequency Dependence of Responsivity




Figure 2. Sensitivity in Dark Ambient




Figure 3. Sensitivity in Bright Ambient




Figure 4. Sensitivity vs. Electric Field Disturbances




Figure 5. Sensitivity vs. Supply Voltage Disturbances





Figure 6. Sensitivity vs. Ambient Temperature





Figure 7. Output Function




Figure 8. Output Function




Figure 9. Sensitivity vs. Duty Cycle




Figure 10. Output Pulse Diagram




Figure 11. Supply Current vs. Ambient Temperature




Figure 12. Relative Spectral Sensitivity vs. Wavelength








Figure 13. Vertical Directivity  $\phi_{\text{y}}$ 






Figure 14. Horizontal Directivity  $\phi_X$ 



#### Ozone Depleting Substances Policy Statement
